- 1. Eligibility.** You (the Student) must be 18 years or older to obtain the Service for yourself. By signing the application form, you represent and warrant that you have the right, authority and capacity to enter into this Agreement and to abide by all of the terms and conditions of this Agreement.
- 2. Term.** This Agreement will remain in full force and effect while you use the Service. You may terminate the Service at any time, for any reason upon receipt of your written or email notice of termination. Campus English Academy (AIC) may terminate the Service for any reason upon issuing Notice to you. Even after the Service is terminated, this Agreement will remain in effect.
- 3. Tuition refund:** AIC shall refund 100 percent of the amount paid for institutional charges, less a \$75 application fee, if notice of cancellation is made through attendance at the first class session, or the seventh day after enrollment, whichever is later. After this date, students who have completed 60 percent or less of the period of attendance shall receive a pro rata refund.
- 4. Cancellation:** We reserve the right to cancel a session or a class at any time. If we cancel a class during the session, we will schedule a make-up or provide a substitute teacher.
- 5. Education.** You represent that your purpose is a vocational or recreational in nature.
